In order to encourage trained, experienced employees to stay with the Appraisal District, all regular full-time employees of the District may receive longevity pay. The longevity allowance granted under this policy is not wages subject to retirement benefits and instead the only deduction associated with such allowance is for Medicare and Federal withholding purposes. All employees on November 1 of each year who is a full-time employee and has accrued at least one (1) year of service (12 consecutive months), may receive an annual longevity allowance based on the District's performance and budgetary constraints at the discretion of the Board of Director's. Longevity will be placed on the November Board of Directors Agenda. If approved the longevity payment will be a single payment made during the next pay period.
